1. Biddings will be conducted through National Competitive Bidding (NCB) Procedure.
2. The construction period is **60 Calendar Days** from the date of award for all contracts in above Table.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered in the field of building construction for Grade C5 or C6 with the Construction Industry Development Authority (CIDA) Formerly known as Institute for Construction Training and Development (ICTAD), valid until the date of award.
4. Interested eligible bidders may obtain further information from Director (Engineering), Development Division, State Ministry of Provincial Councils & Local Government Affairs T.P: 011-2337182 and inspect the Bidding Documents at the **Finance Division of this Ministry** from **01st October 2021 to 22nd October 2021** on normal working days (**from 9.00 a.m to 3.00p.m**)

A complete set of Bidding Documents in English language may be purchased by interested Bidders on the submission of a written application to the address below from **01st October 2021 to 22nd October 2021 from 9.00am to 3.00pm on working days**, and upon payment of a non-refundable fee. The method of payment will be in cash at the **Finance Division of this Ministry**.
6. Bids must be delivered to the address below on or before **25th October 2021 at 2.00 p.m.** and late bids will be rejected. Bids will be opened soon after closing of bids at **Finance Division of this Ministry**. Bidders or their authorized representatives are requested to be present at the opening of bids. **“Construction of Library Building at Walikanda”** Should be written on top left hand corner of the envelop.
7. Bids shall be valid for a period of **77 Days** from the last date fixed for receiving of Bids or any extended period.
8. To qualify for award of contract for every bid where tenderable amount exceeds of LKR.5.00 Mn bidder shall submit the certificate issued by the register of companies under the paragraph 8, of public contracts Act no 03 of 1987

9. All Bids shall be accompanied by a Bid Security which shall be;
